CHARTER

REVIEWED BY THE ORGANISING TEAM FOR THE 5TH AMLMUN SESSION

This document outlines the rules of behavior expected from Delegates of AML MUN. It is a legal document between the AML MUN Organizing Team and Delegates/Staff/Chairs/Guests. All must commit, through signing the Consent Form that explicitly mentions the Charter, that they have been informed and understand the responsibilities that fall on them as laid down in the policies and extracted in the Charter. Participation in the event is conditional on having agreed to this document. A signature of a legal guardian is also required.

Code of Conduct

Dress Code

The Dress code follows MUN regulations and traditions. Participants are required to dress in formal, business attire during all conference sessions. Ladies and gentlemen can wear:

- Formal shirt,
- Suit jacket or blazer,
- Formal trousers, skirts, or dresses,
- Tie or bow tie (mandatory for male delegates),
- Formal shoes.

Prohibited Dress and Accessories include:

- Political slogans or insignia
- Clothes and Accessories which are inappropriate
- Casual, non-formal clothing

Prohibitions

- Alcohol, Drugs and Smoking are strictly prohibited in AML premises!
- Participants in the AMLMUN are not permitted to use or even have in their possession any life-endangering objects that have the capacity to cause bodily harm.

Behavior

Participants are required to treat one another with respect. This encompasses fostering a friendly and inviting atmosphere for every participant, avoiding behavior that is unjust or harmful to others. honoring cultural, religious, and individual variances and

avoiding discrimination toward any other participant based on their age, sex, or gender, identity, sexual orientation, physical or mental disabilities, faith, national or ethnic group background, family situation, relationship status, or any other condition.

Bullying or harassment in any form—be it verbal, non-verbal, physical aggression, or sexual, or emotional- is unacceptable. This encompasses all types of digital harassment or bullying.

The advisors from each school are solely responsible for the behavior of the students that they escort.

Participants should not cause damage to the premises of the school or the school's property. Any damage caused must be paid by the participants themselves or their parents if they are under 18 years of age.

Participants must follow the instructions of the Organising Team at all times.

Moreover, any damage caused to the placards or the badges is not acceptable. Those responsible will incur the cost required for their replacement.

Emergency Situations

Earthquakes

During an earthquake, everyone must stay composed. Participants should cover their head under their desks until the shaking has ceased and only then should they neatly exit the rooms. Chairs and staff ought to guide the delegates of their committee to the gathering locations and ensure that everyone has exited the room safely. The building's evacuation should take place. Participants must stay on the yard surrounding the school and await instructions from the Organising Team. Parents or guardians will be reached out to for the purpose of collecting their children.

Floods, fires or other natural disasters

During an emergency, such as a flood or fire, leaving the building is necessary and must be carried out safely following the directions and guidance of the organizing committee, at the most suitable time and with the most suitable style. Parents or guardians will be notified to collect their children.

Medical Emergencies

Due to the lack of medical support at the conference, an ambulance will be summoned in the event of a medical crisis.



Attendance

Attendance to all sessions is mandatory for the delegates who wish to receive a certificate. If, due to a significant reason, a delegate cannot take part in any segment of the conference, they must notify their advisors and the chairs of their committee, who will reach out to the Organising Team.

Consequences

Any participant violating this Charter can be expelled from the conference by any member of the Organising Team.
